Recently, the Supreme Court of the United States ruled on a case that had the ability to extremely limit pregnancy clinics like Birth Choice, if not permanently close their doors. California passed a law that would require every pregnancy center in that state to post very visible signs in their clinics referring their clients/patients to the closest abortion clinic. There is definitely something to the saying, "As California goes, so goes the nation...." If the Supreme Court upheld this law, abortion clinics and pro-abortion organizations would have used it as a precedent to make it law in every state in the country. This would mean that Birth Choice would be required by law to post a sign referring clients to the nearest abortion clinic.

I'm grateful that the California law was challenged by prolife organizations and their attorneys, eventually bringing it before the Supreme Court. Once there, attorney Tom Glessner who spoke at one of our banquets a few years back was the very pro-life, Christian lawyer who argued the case. Praise God, in a split decision, the Supreme Court justices ruled that the California law was in fact unconstitutional. It was a huge victory for the pro-life community and the 4,000 pregnancy centers across the nation.

I can't help but think, "What if our pro-life President's opponent had won? What if conservative judge Neil Gorsuch hadn't been recently added to the Supreme Court or if his nomination had been held up until after this case was decided?" If SCOTUS had ruled against us, then the constitutional right of free speech would have been taken away from every prolife pregnancy center in the nation. It could then be used to take away free speech from many other Christian organizations as well.

If SCOTUS had not ruled in our favor, many pregnancy centers across the nation would have closed their doors because of refusal to comply with the law or being fined out of existence. The leadership of some pregnancy centers would have chosen jail by refusing to comply with that law. I would have been one of them. And how many more children would have been sacrificed? Our nation would have slipped into – no, jumped into an even larger cesspool of human degradation.

For now pro-life Americans have received a reprieve and Birth Choice will continue to fight for the dignity and the lives of unborn children and their mothers. We thank each of you for believing in and trusting us to defend the most helpless of our society.

### **MOBILE UNIT UPDATE**

We are continuing to move forward in this much needed addition to the Birth Choice ministry.

In the coming weeks we will be officially working to secure the \$155,000 needed to purchase the vehicle. We will also be building new relationships with pro-life churches in some of the unreached areas of West Tennessee. We hope this will help secure the ongoing daily operational costs of the unit, an additional \$38,000 per year. Our goal is to have this vital part of our ministry up and running by our 2019 Banquet. Hopefully we will have it before then if we are able to secure those funds. ### FROM THE HEART OF A VOLUNTEER NURSE KIM CUPPLES

Ultrasound Nurse

I have volunteered with Birth Choice for about eleven years. My first year I served as a client advocate and for the past ten years I've served as ultrasound nurse. I was looking for a ministry opportunity when I heard about Birth Choice during an Englewood church service. I thought I was joining this ministry to help other people, but have been blown away by the changes this ministry has had on me. The accountability that goes along with the responsibility is amazing. The clients are varied, but so are the volunteers. We each bring our own strengths and weaknesses to the divinely anointed appointments. I have had people say to me that they could never do what I do. That is so inaccurate. I just show up, be myself and let the Holy Spirit take over. Some of the best interactions with clients have happened when I came to work totally against Satan's best efforts. I have been an RN in women's and children's services for 34 years and the flicker of a new heart beating still warms mine.

One of my favorite perks is getting to hold the babies that come back to see us after they are born. I also appreciate the hugs that the broken women often need. I encourage you to allow these women to touch your hearts as well. The connections that we are able to make with some of our clients are fleeting, but some will last a literal lifetime.

It has meant so much to me to be a part of Birth Choice. I thought I was coming to help other women not make the same mistake I did and to try to prevent them from dealing with the emotional trauma that comes with abortion. During the 2016 campaign season and beyond, the prolife community has awaited the promised federal defunding of Planned Parenthood. This organization receives over I million per day of our federal tax dollars to keep the wheels of evil turning in the destruction of our

Since the promise has yet to come to fruition, many states have enacted laws to prevent state tax dollars from being funneled to Planned Parenthood. Tennessee's Governor Bill Haslam has recently followed suit. Governor Haslam signed two new laws to ensure that no state tax dollars go to Planned Parenthood and other groups that do abortions. The Title X family planning funds

will be directed toward health departments and other nonprofit providers rather than abortion clinics.
